## **2020 HITS HOLIDAY SERIES (OCALA, FL) VENDOR CONTRACT:**

### **WHAT IS NEEDED TO COMPLETE APPLICATION**

✔ **Two Week Stay Minimum**

✔ **Two Week Deposit**

✔ **Proof Of Insurance**

✔ **State Sales Tax Certificate**

✔ **Completed Contract**

✔ **Open Check or Credit Card to be kept on file**

### **TERMS AND CONDITIONS**

Our policy is to accept Vendors as space permits, while limiting the number of Vendors with similar wares. All vendors of products displaying the HITS logo or verbiage require prior written approval by HITS. Vendors may be excluded due to conflicts with established sponsorship arrangements. Food and beverage vendors are not permitted. Subletting of vendor space is strictly prohibited. Priority is given to Vendors attending the entire circuit. HITS reserves the right to reject any application for any reason. No vendor location can be guaranteed. A two consecutive week minimum stay is required.

Potential vendors must submit a deposit equal to two weeks of complete vendor fees. If the application is accepted the deposit is non-refundable and will be applied toward the last two weeks of the vendor's stay. In the event that the applicant's contract is not accepted, the deposit will be fully refunded. HITS may deposit an applicant's check and later choose to reject their application, in which case a refund will be sent to the applicant.

**Please be advised that the application does not constitute a contract with HITS until each of the following three requirements are satisfied:**

- HITS notifies the applicant via email or letter, that they have been identified as a potential Vendor.
- The applicant provides satisfactory copies of the requisite insurance certificates, sales tax and/or business licenses set forth below.
- HITS receives a two week deposit to guarantee a vendor space.

#### **Insurance, Sales Tax, and Business License Requirements:**

A current certificate of insurance evidencing a policy of One Million Dollars (\$1,000,000.00) per occurrence, Two Million Dollars (\$2,000,000) aggregate in Combined Single Limit Bodily Injury and Property Damage insurance, including products/completed operations naming HITS Holding Corporation and HITS, Inc., doing business in Florida as HITS Ocala as Specifically Designated Additional Insured. A certificate of insurance for Workers' Compensation and Employment Liability in the amount of no less than One Hundred Thousand Dollars (\$100,000.00) per occurrence.

#### **And**

A photocopy of your Florida State Certificate of Authority to Collect Sales Tax, which serves as evidence that you have met the sales and use tax registration requirements for that jurisdiction and that you are authorized to collect and remit tax as required by law.

Failure to satisfy these requirements prior to your arrival will preclude you from vending at the show; and result in the forfeiture of your deposit.

### **PAYMENT**

- **Please make checks payable to HITS, Inc.**
  - **A deposit equal to a minimum two weeks of Vendor Space is required with your contract.**
  - **An open check or credit card MUST be filed in the Horse Show Office.**
- This will be held until the last unpaid week of your vendor stay

- **Payment is due in the horse show office on the first day of the show each week.**

Non-payment will result in the open card or check being charged for the remainder of the vendor's stay

### **MAIL SERVICE**

**HITS is not responsible for mail or parcel deliveries made to vendors, exhibitors or others by US mail, FedEx, UPS or others.**
